Greenfield Winter Carnival Parade of Lights Registration



Parade Date & Starting Location:

Friday, February 2nd, 2024 at 6:00pm SHARP. Entries will line up at the Newton School parking lot, 70 Shelburne Road, Greenfield. Line-up begins at 4:30pm. All entries need to be lined up by 5:30pm and completely decorated and ready to go by 5:45pm. The parade will not wait for late arrivals.

Parade Route:

Right out of Newton School Parking lot. Left from Shelburne Road onto Mohawk Trail/ Main Street. Continue down Main Street. Turn left onto Federal Street. Continue on Federal. Turn right onto Beacon Street. Cross High Street toward Beacon Field. End at Beacon Field along Gerrett and Beacon Streets.

Deadline:

All entry forms must be submitted by January 12th. Entries are accepted on a first come- first serve basis. In the event the amount of entries exceeds the amount of space needed for the parade line-up, we declare the parade "full" and accept no additional entries.

Judging & Prizes:

Judging will take place at Beacon Field at the end of the parade. Awards will be announced in the following categories at the Winter Carnival Award Ceremony on Sunday, February 4th, 3:45pm at Beacon Field. Winners will be notified.

Best and Brightest Award
Artistic Illumination Award

Rules & Regulations

1. **WALKERS are NOT allowed** in the parade. ALL participants must be on a float or in a vehicle.
2. **Throwing of any candy or objects is strictly prohibited** for the safety of all parade participants and for the safety of spectators. Anyone violating this rule will be removed from the parade immediately.
3. Entry dimensions should not exceed 75ft long, 12ft high, 12ft wide.
4. All entries must be decorated with a minimum of **500 lights**.
5. Christmas lights should be turned off until vehicle is lined up for the parade. Decorative lights must be off on your way to and from the parade.
6. The content, costuming, and music of all entries must be appropriate for a family audience.
7. During the parade, vehicle headlights **MUST BE TURNED OFF**.
8. No one may get off or on a float or entry once the parade has begun.
9. All movement must be in a continuous forward motion. Stopping or performing in place will not be permitted.
10. No smoking or alcoholic beverages on any parade entry at any time before or during the parade.
11. Fireproof or fire-resistance materials should be used on all floats. A fire extinguisher is recommended to be carried by each entry. All gas-powered generators must have an ABC Fire Extinguisher.
12. Drive safely. Vehicles in the staging area must maintain a safe rate of speed not to exceed 5 mph. Additional vehicles will not be allowed in the staging area due to limited space.
13. Please make sure your vehicle, generator, sound equipment, etc is in good working order. If you stall on the parade route, you will be asked to exit the parade.
14. A written description of your entry is required with the application. It should be informative and complete.
15. The Parade Inspection Committee will be checking each entry at the staging area for compliance to the rules. If any entry is in poor taste or not in compliance, the Committee will have the authority to remove that entry before the parade.
16. **SAFETY COMES FIRST!!!** The parade will commence rain, snow, or shine, but if at any time leading up to or on parade day the weather and/or street conditions are deemed unsafe, the parade will be canceled. That decision will be made by 12:00pm on February 2nd. We will communicate any cancellation via Rec Dept voicemail, email, and social media.
